# COMMISSION REPORT



Highlights of approved items by the City of Casselberry City Commission July-September 2020.

#### **ORDINANCES**

- Ordinance 20-1537 amended Chapter 86 of the City Code of Ordinances, Utilities, Article II, Sewers to update the City's Industrial Wastewater Pretreatment Program.
- Ordinance 20-1535 approved the Voluntary Annexation of 3110 Howell Branch Road and 3128 Orava Lane.
- Emergency Ordinance 20-1538 deferred the October 1, 2020 Utility rate increase scheduled to go into effect October 1, 2020 until April 1, 2021.

#### **RESOLUTIONS**

- Resolution 20-3173 approved a funding agreement with Metroplan Orlando for fiscal year 2020-21.
- Resolution 20-3174 is the Annual Rate Resolution for the Fiscal Year 2020-21 assessment roll for the special assessment associated with the replacement of the Sausalito Shores subdivision wall.
- Resolution 20-3177 approved an agreement with Sara Brady Public Relation, Inc. for Professional Public Relations, Consulting and Marketing Services.
- Resolution 20-3178 approved a School Resource Officer Agreement with the School Board of Seminole County for a School Resource Officer at South Seminole Academy for the 2020-2021 school year.
- Resolution 20-3182 approved the Street Lighting Final Assessment for the provision of street lighting services for fiscal year 2020-21.
- Resolution 20-3183 approved a Local Agency Program Agreement with the Florida Department of Transportation for the Winter Park Drive Complete Street and Concept Development Study.
- Resolution 20-3188 approved a Land Lease Agreement and a related Memorandum of Land Lease Agreement with Cellco Partnership d/b/a Verizon Wireless for a cellular tower at the City water tower property on Hunterfield Rd.
- Resolution 20-3189 approved an exclusive franchise agreement for commercial solid waste services with WCA of Florida, LLC for frontload dumpster, cart, compactor and otherwise putrescible solid waste.
- Resolution 20-3190 approved an exclusive franchise agreement for commercial solid waste services with WCA of Florida, LLC for open top, roll-off containers for non-putrescible solid waste.
- Resolution 20-3197 approved an Interlocal Agreement with Seminole County for CARES Act Funding.
- Resolution 20-3198 recognized Mayor Charlene Glancy for her 12 years of dedicated public service to the Casselberry community as Mayor/Commissioner.
- Resolution 20-3199 approved the final City millage rate of 2.9990 mills for fiscal year 2020-2021.
- Resolution 20-3200 approved the final City operating budget in the amount of \$82,695,700 for fiscal year 2020-21.
- Resolution 20-3204 amended the City Commission Meeting and Agenda Policies by changing the commencement time of regular City Commission meetings from 5:00 p.m. to 5:30 p.m.

- Approved extensions to existing non-exclusive franchise agreements to extend commercial solid waste services provided to businesses in the City through December 31, 2020.
- Confirmed the August 18, 2020 City election results and provided the oath of office to Mayor David Henson.

#### **WEAR YOUR FACE COVERING CORRECTLY**

- · Wash your hands before putting on your face covering
- Put it over your nose and mouth and secure it under your chin
- Try to fit it snugly against the sides of your face
- · Make sure you can breathe easily
- Do not place a mask on a child younger than 2







#### **USE THE FACE COVERING TO HELP PROTECT OTHERS**

- Wear a face covering to help protect others in case you're infected but don't have symptoms
- Keep the covering on your face the entire time you're in public
- Don't put the covering around your neck or up on your forehead
- Don't touch the face covering, and, if you do, clean your hands

#### **FOLLOW EVERYDAY HEALTH HABITS**

# EXECUTIVE ORDER REGARDING THE USE OF SOCIAL DISTANCING/FACIAL COVERINGS IN SEMINOLE COUNTY

#### **DEFINITIONS**

"Face Covering" - shall mean a uniform piece of material that securely covers a person's nose and mouth and remains affixed in place without the use of one's hands, whether store bought or homemade, concurrent with CDC guidelines.

#### MINIMUM STANDARDS FOR BUSINESSES AND PLACES OF ASSEMBLY

All places of assembly, businesses, and other places open to the public in Seminole County shall follow these conditions, unless precluded by any order issued by the Governor for the State of Florida or if social distancing would preclude the provision of service to a customer, such as in a hair salon, nail salon, or other similar personal services:

- 1. All persons, employees, patrons, and participants must practice physical distancing by staying at least six (6) feet apart (hereinafter "social distancing");
- 2. Meetings, workshops, training programs, and other modes of assembly must ensure appropriate social distancing; and
- 3. Checkout points and staging areas, including storefronts, must be monitored for social distancing requirements by means of marking floors or similar actions to maintain social distancing between patrons and employees.

Businesses that provide services requiring employees and patrons to be within six (6) feet of one another, such as hair or nail salons, are subject to all other provisions of this Order.

#### **FACE COVERINGS REQUIRED**

Every person working, living, visiting, or doing business in Seminole County is required to wear a Face Covering consistent with the current CDC guidelines while at all businesses, places of assembly, and other places open to the public. This section does not apply to individuals that are exempt from wearing Face Coverings, as stated in this Order.

#### **FACE COVERINGS OUTDOORS**

A Face Covering is not required at outdoor businesses, places of assembly, and other places open to the public if social distancing, as described in Section 2 of this Order, can be accomplished.

#### **EXCEPTIONS**

A Face Covering shall not be required for the following persons:

- 1. Persons under the age of two (2) years;
- 2. Persons for whom a Face Covering would cause impairment due to an existing health condition or disability;
- 3. Persons working in a business or profession who are not interacting with the public and who are able to maintain social distancing from co-workers;
- 4. Persons working in, or patrons of, a business or profession where use of a Face Covering would prevent them from performing the duties or receiving the services of the business or profession;
- 5. Persons exercising, while maintaining social distancing;
- 6. Persons eating or drinking;
- 7. Public safety, fire, and other life safety and health care personnel, as their personal protective equipment requirements will be governed by their respective agencies; and
- 8. Persons communicating with someone who is hearing-impaired and must see the mouth of someone wearing a Face Covering in order to communicate.

#### **PENALTIES**

This Order is intended as a measure to seek voluntary compliance with the provisions contained in the Order and to educate and warn of the dangers of noncompliance.

#### **APPLICABILITY**

This Order is in addition to the Executive Orders issued by Governor DeSantis and Seminole County. Any provision(s) within this Order that conflict(s) with any State or Federal law or constitutional provision, or conflict(s) with or are superseded by a current or subsequently-issued Executive Order of the Governor or the President of the United States, shall be deemed inapplicable and deemed to be severed from this Order, with the remainder of the Order remaining intact and in full force and effect. This Order applies to incorporated and unincorporated Seminole County, but has no application outside of the County.

# **Upcoming Utility Projects**



#### Seminola Master Lift Station Renovation

Construction is currently underway on the rehabilitation of the largest City-owned lift station in the City's sanitary sewer system. This lift station, located near Lake Kathryn Circle on Seminola Blvd, pumps approximately 300,000 gallons per day of wastewater to the City's Water Reclamation Facility. Rehabilitation of the lift station will include the installation of a new underground wet well (shown in the picture to the right), three new pumps, a new generator and fuel tank, new pipes and valves, and a new control panel. Construction on this project is expected to be complete by early 2021.



# Howel Park WTP Improvements In the state of the state of

#### **Howell Park Water Treatment Plant Rehabilitation**

The Howell Park Water Treatment Plant will be completely rebuilt by the end of this year. Construction began in January 2020 to replace everything inside the plant except the two ground storage tanks and the wells, including the high service pumps, the chemical storage and injection equipment, the electrical and control systems, and the building. The plant was first built in the 1960s and has received numerous additions and modifications since then. These upgrades will improve the resilience of the City's drinking water system and ensure the City is able to continue to provide high-quality drinking water to all its customers.

#### **Water Reclamation Facility Improvements**

The City's Water Reclamation Facility, which treats approximately one third of all wastewater produced in the City's sewer service area, is currently under construction. Improvements to the facility include the rehabilitation of the filters and the chlorine contact chamber as well as replacement of the transfer pumps and some of the effluent pumps. The Water Reclamation Facility was originally constructed in the 1950s and these improvements will help extend the lifespan of the facility. Construction is expected to be complete by early 2021.

# Becoming the Walkable and Rollable City: Concord Drive Improvements



Construction of Concord **Drive** Improvements is scheduled to begin October 26, 2020 and continue until late June 2021. Concord Drive connects Anchor Road to US 17-92 and is fronted by a combination of residential and commercial properties. Concord Drive has nuisance drainage issues, where water tends to pond and even obstruct the sidewalk. There are also gaps in the sidewalk, and there is a water main in need of replacement. The Concord Drive Improvements project will address these key issues and much more.

The project will reconstruct the road from Anchor Road to N. Cypress Way, installing new drainage improvements and new 6-foot wide sidewalk separated from the road by raised curb. A pond will be constructed on vacant City-owned lots on the south side of Lake Lotus to intercept stormwater runoff before it discharges to the lake. This area will also be landscaped with several Florida-native and Florida-friendly trees and shrubs. A boat ramp (for City official use only) will also be installed at this location so the City can better control invasive aquatic plants on the lake. Colorized concrete crosswalks will be installed at Lotus Lane and N Cypress Way. The N Cypress Way intersection will also receive brick accent treatments for both aesthetics and traffic calming. An existing water main will also be replaced. From N Cypress Way to US 17-92, sidewalk gaps will be filled, the road will be microsurfaced, and drainage swales will be installed.

Both Lotus Lane and Lotus Lake Drive will also be microsurfaced, providing a fresh new appearance. In addition, a new emergency overflow pipe will be installed to reduce flood risk for homes on Lake Lotus during major storm events.

The City of Casselberry has set a goal to become the most walkable, rollable, and bikeable City in Central Florida by the year 2040. Construction of the Concord Drive Improvements project will help achieve this goal by creating a safer and complete sidewalk that will be accessible for people walking and rolling (e.g., using wheelchairs or other assistive devices.) The project is being funded by a combination of Penny Sales Tax, Gas Tax, Stormwater Utility Fund, Water/Sewer Utility Fund, and the City's Tree Replacement Fund. #### Community Rating System (CRS) Recertification is Approved

The Community Rating System (CRS) is a voluntary, incentive-based community program that recognizes, encourages, and rewards local floodplain management activities that exceed the minimum standards of the National Flood Insurance Program (NFIP). The goals of the CRS are to reduce and avoid flood damage to insurable property, strengthen and support the insurance aspects of the NFIP, and encourage a comprehensive approach to floodplain management.



In 2019, the City of Casselberry was awarded a Class 8 rating, which gives City residents the 10% discount in the premium cost of flood insurance for National Flood Insurance Program (NFIP) policies issued or renewed in Special Flood Hazard Areas (SFHAs) on or after October 1, 2019. This May, the City filled in the recertification forms, met all the annual recertification criteria and is recertified again as Class 8. The City has also been coordinating with Seminole County to update the Floodplain Management Plan.

# ADVANCED METERING INFRASTRUCTURE (AMI) INSTALLATION PROJECT

As part of our ongoing system-wide improvements to ensure efficient delivery of safe, high-quality water to the residents we serve, the City of Casselberry has begun a system-wide water meter upgrade. The City has already installed AMI for 200 meters City-wide as part of a pilot study. It is anticipated that the next phase of the installation process will continue through 2021. There is no action that you will need to take. The installation work will be done by a City-approved vendor, VEPO Metering. All contractors working on the project will have undergone a background check and will be identifiable by their City-issued photo ID badge, which they are required to wear at all times. Contractor vehicles will also be identifiable by their VEPO Metering decals. **Please note that at no time should these contractors need to enter your home.** 

#### **HOW IT WORKS**

Data from the meters is encrypted and sent through a secure network to utility databases. The meter system transmits only the water meter readings, the meter identification number, and diagnostic information to verify that the automated meter equipment is operating correctly.

#### WHAT IS AMI?

Advanced Metering Infrastructure (AMI) provides our residents with an improved meter read and billing accuracy. This state-of-the-art technology will provide water usage data in real time and detect leaks or issues immediately, leading to a faster response time and an increase in customer satisfaction.

#### WHAT TO EXPECT DURING INSTALLATION

- You will receive postcard in the mail a couple of weeks prior to the installation taking place.
- On the day of installation, a VEPO contractor will knock on your door prior to the commencement of the installation in order to notify anyone in the house that the work is being performed. If there is no answer and the current meter is not reading any water usage, work will commence. If the current meter is reading water use, the contractor will bypass the house and return later in the day.
- The installation process will take approximately 30-45 minutes and does not require the resident to be at home.
- Water service will be temporarily stopped for 20-30 minutes during the installation.
- Upon completion of the work, the contractor will notify the resident that the installation is complete by knocking on the door. If the resident is not home, a notification will be placed on the front door knob indicating completion of the installation.

#### FREQUENTLY ASKED QUESTIONS

#### Q: What exactly will be installed at my property?

A: The new system consists of an integrated meter and radio transmitter. Meters greater than 5 years old will be replaced with new meters and transmitters. Meters less than 5 years old will remain in service and be retrofitted with radio transmitters.

#### Q: Will I pay more for water as a result of the change?

A: Your water rate will not change due to the installation of the new meter. You will not be charged for the installation of this meter. You may notice changes in your water bill since your water usage will be more accurately reflected.

## Q: What if there is a leak at the meter or any other problem after the meter is replaced?

A: The door hanger that will be left by the contractor after the meter installation is complete will have a phone number on it. Please call this number if you experience any leaks or other problems after the meter is replaced.

#### **KEY BENEFITS OF AMI**

- Improved data analysis will allow the City and you, the customer, to detect leaks earlier, saving both money and water.
- The time it takes the City to respond to emergencies or issues will be decreased as the AMI will notify us of such issues.
- Meter reading will be more precise, thus leading to more accurate billing.
- Accurate, real-time data will allow for quicker resolution to billing questions.
- Older, aging meters will be replaced with state of the art equipment.

# **NEW RESTAURANT INCENTIVE PROGRAM**



Residents want more restaurants and the City of Casselberry heard!


In January, the Casselberry City Commission adopted a new incentive program to help restaurants share the cost of eligible oil and grease interceptor systems and installations. The program provides a 50% reimbursement, up to \$15,000, after the successful permitting, installation, and inspection of eligible restaurant improvements. Approved interceptor systems are required for every restaurant and food service establishment connecting to the Casselberry sewer system, and they are not cheap!



Q: Why do I need an expensive interceptor system for my restaurant and food service business?

A: If left unregulated, commercial fats, oils, and grease can build up in sewer systems creating blockages, environmentally disastrous overflows, and very expensive maintenance costs. Casselberry is committed to environmentally sustainable practices





through its Oil and Grease Management Program. The incentive program is intended to help eligible restaurants and food service establishments offset the costs of interceptor systems required by these regulations.

The City of Casselberry is requesting residents sort recyclables **BEFORE** placing curbside. Generally curbside sorting is done by the hauler, but for the safety of the collection crews, it is requested that customers self-sort.

Please note that tissues and paper towels should be placed in regular household garbage.

Sorting guidelines are as follows:

#### Fibers should be sorted together. This includes:

- Pasteboard (i.e., cereal boxes, empty paper towel and toilet paper rolls, soda boxes, beer boxes, tissue boxes, gift boxes, pizza boxes and shoe boxes)
- Brown paper grocery bags (no wax, no wet strength material, no liners)
- Corrugated cardboard (flattened and cut down to fit inside the recycle bin)
- Newspaper, supplements, magazines and catalogs
- · Box board, carrier stock, white and colored paper
- Telephone Books

#### <u>Co-mingled containers</u> should be sorted together. This includes:

- Plastic Containers #1-7 (#'s on bottom of containers) Remove all lids
- · Glass bottles and jars (clear, green and brown) Remove all lids
- Aluminum cans
- · Steel cans and tin household containers, such as food cans

# Recycling Plastics 101

Recycling plastic can be complicated! Here is a quick guide to better understand what the numbers on your plastic items mean.





#### **PETE - Widely Accepted**

soft drink bottles, mineral water, fruit juice container, cooking oil





#### **HDPE - Widely Accepted**

milk jugs, cleaning agents, laundry detergents, bleaching agents, shampoo bottles, washing and shower soaps





#### V - Rarely Accepted

trays for sweets, fruit, plastic packaging (bubble foil), and food foils to wrap the foodstuff





#### **LDPE - Rarely Accepted**

crushed bottles, shopping bags, highly-resisent sack and most of the wrapping





#### PP - Moderaterly Accepted

furniture, consumers, luggage, toys as well as bumpers, lining and external borders of the cars





#### **PS - Rarely/Never Accepted**

toys, hard packaging, refrigerator trays, cosmetic bags, costume jewelry, CD cases, vending cups





#### OTHER - Rarely/Never Accepted

acrylic, polycarbonate, polylactic fibers, nylon, fiberglass

NOTE: Plastic bags/wraps typically do not get recycled in curbside bins. However, it often can be returned to participating drop-off locations such as retail stores for recycling.

#### The Casselberry Police Department Brings You the 9 PM Routine

As a crime prevention strategy, the Casselberry Police Department has joined other agencies across the country with promoting the **#9PMRoutine** via social media.

The **#9PMRoutine** is a social media campaign to raise awareness and highlight how to prevent home and vehicle burglaries. There are four main steps to follow:

- Step 1. Take any valuables out of your car and make sure there are no items visible from outside of your vehicle.
- Step 2. Secure all doors of your vehicle and lock your car.
- Step 3. Lock and secure your front and back doors. If you have a side or garage door, you might want to make sure those are secure too.
- Step 4. Turn exterior lights on.

The **#9PMRoutine** is a daily social media post to remind the public to complete the steps above. Although 9 P.M. is the time given, these steps can be used at any time of the day to help keep one's self and property safe. Remember the **#9PMRoutine**!

## **Holiday Tips from the Casselberry Police Department**

#### The Casselberry Police Department has provided these helpful holiday shopping safety tips!

- **1. Shop online.** This option has so many benefits, primarily the ability to shop safely from the convenience of your own home, day or night. Besides the safety aspect, you can avoid fighting the crowds, stay warm inside, save gas, and do it all without having to put on shoes! Just make sure you're shopping on reputable websites, and keep a record of all transactions and confirmation numbers. Have your items shipped to a location that doesn't require the delivery driver to leave packages on your porch, unless you plan to be home. It's too easy for criminals to swipe your gifts and get away.
- 2. If you decide to go out shopping, carry only what is absolutely necessary. Most people use debit or credit cards for purchases. Stick your driver's license and credit card (or cash), phone and keys in your pocket. Not only does carrying a purse attract the attention of thieves, it also requires you to keep track of it while you're shopping. If you do carry a purse, don't leave it sitting in the shopping cart unattended or on top of the car when loading groceries or packages and make sure it has a sturdy strap that you can wear in cross body fashion.
- **3. Dress casually and comfortably. Also, avoid wearing flashy jewelry.** That's a neon sign telling criminals that you are a valuable target. Appear physically prepared in order to deter a criminal from targeting you by walking with confidence. Making eye contact also sends a signal that you've seen them and could identify them.
- 4. When possible, shop during the day and consider taking a friend with you there is safety in numbers, not to mention shopping is more fun with a companion. Darkness allows criminals to avoid being seen as easily. Park as close to the entrance as possible, and near a light pole if you'll be returning to your car after dark. Cart racks make excellent places to park, and place your vehicle's driver's door on the same side as the cart return rack for a little extra protection.
- 5. If you see someone hanging around the parking lot, don't hesitate to leave and go elsewhere. If you're leaving a shopping center and see anything suspicious, turn around and go back inside. Ask an employee or security guard to walk out with you. Trust your gut instinct. If it doesn't feel right, it probably isn't. It is common for our brain to try to "normalize" the situation and enter a state of denial, which is known as normalcy bias. In Amanda Ripley's book, The Unthinkable, she states that people procrastinate acting on their instincts because they risk social embarrassment by overreacting. So, we err on the side of underreacting instead.
- **6. Keep one hand free.** Avoid overloading yourself with shopping bags and buy only what you can carry. Have your keys in your hand before leaving the store. Fumbling in your pocket or purse to find them takes your focus off your surroundings and also delays your ability to get into your car. Once inside, lock the doors and leave. The parking lot is not the place to return phone calls, texts or emails.
- **7. Put your phone away.** Talking or texting will take your attention off what's going on around you. Often times, people are seen walking around with earbuds in their ears. Please don't. Your sense of hearing is important to your well-being. Situational awareness is the best way to identify a threat ahead of time and avoid the encounter entirely. Just as eating right and exercising are good ways to help prevent health issues such as a heart attack, paying attention to surroundings can help prevent a bad situation from happening.
- **8. Don't leave your packages or valuables in plain sight. This is an invitation to thieves.** Lock them in the trunk or somewhere that's less visible than your front seat. When you get home, pull into your garage and close the door down before getting out to unload your gifts. Also, when you drive down your street or pull into your driveway, check your rearview mirror to see if you've been followed home.
- **9.** At this time of the year, it's easy to get sentimental and feel generous. Criminals will use that to their advantage. Common distraction tactics involve asking for money, a cigarette, or even the time, which gives them the opportunity to catch you off-guard. Remember to keep some distance between you and others, and don't feel bad about saying no.
- **10. Be Aware of Your Surroundings.** It's important to be observant of your surroundings at all times. In particular, be sure to make a note of where you have parked your vehicle so that you're not intent in wandering around the parking lot in search of it after you have finished shopping.

With all the hustle and bustle and distractions of the season, don't forget about safety.



## The Casselberry Sculpture House


The development of the Casselberry Sculpture House, located at 120 Quail Pond Circle, got very colorful recently with the addition of an amazing new mosaic mural! The mosaic initiative kicked off in late August, when the City held the "Bring Your Bubble" Mosaic Workshop, which invited entire households to bring their bubble to take part in the assembly of the roughly 300-square foot artistic puzzle. This workshop was sponsored by Casselberry Seniors for a Better Community, made possible by a grant from the Seminole Cultural Arts Council, and several local seniors participated in this socially-distanced and safe workshop.





With a design by artist Claire Lavin, who previously created the iconic mosaic that adorns the front of the Casselberry Art House, several families, from elementary to retirement age, came out one bubble at a time for 90-minute blocks, placing colorful ceramic segments,

mirror tiles, and glass beads on large construction foam panels while working outside under a covered workspace outside the Sculpture House. The City







Under Claire's guidance, volunteers from the community, as well as artists from the Florida Sculptors Guild and members from Casselberry Friends of the Park, each lent their time and energy to assembling, grouting, polishing, and finally, installing the colorful piece on the front of the Sculpture House. The Casselberry Recreation Division, with help from the City's Facilities employees, completed the final installation in October.

The next step in the development of the Sculpture House will be the installation of a metal roof before

the end of the year, and artists and volunteers are slated to assist with landscaping and further artistic improvements to the exterior that will complement the new mosaic. The Sculpture House will be used to exhibit work of local and national sculptors, host classes, workshops, and discussions on 3D artwork, provide studio space, and serve as a permanent home for the Florida Sculptors Guild, who will hold its monthly meetings there, as well as work with City staff to help program regular workshops and sculpture exhibits.




